Course Description

In Principles of Public Relations you will learn about the theory and practice of public relations, how public relations operates in organizations, its impact on publics, and its functions in society. You will study the professional development of the field; concepts, issues, and principles in the practice; and models and theories guiding the practice. You will apply course materials to public relations program planning and management by working in a group on a strategic planning project.

For those planning public relations careers, this course provides a foundation for the public relations major. The course also meets the needs of those planning other professional and managerial careers that can benefit from an understanding of public relations concepts and management practices. You must earn no lower than a "C" in the course to successfully complete the course and move on to other upper-level public relations courses.

Prerequisite: Sophomore standing

Course Format

This semester, due to COVID, this course will include asynchronous and synchronous components. Each week you will have readings, posted the lectures to watch/listen to, and assignments. We will also meet weekly as a class to discuss specific specialties, focus areas and skills. All of this comes together in your four exams and the large project due at the end of the semester. You must keep up with the readings to fully understand issues and intelligently contribute to our classroom discussions. It is in your best interest to fully engage yourself because what you learn will help you make important decisions in the future.

- Understand the basic theories, principles, concepts and practices relevant to public relations.
- Understand key processes involved in public relations, including goal, research, planning, strategy, implementation, and evaluation.
- Gained an international perspective of public relations.
- Gained insights into the different types of public relations industries and careers.
- Demonstrated proficiency in written and oral communications.

Attendance

While attendance is not required for this course, it is expected – I appreciate attendance so much that I will provide extra credit for attending each synchronous meeting. Each class meeting is worth one point that will be applied to the exams. In other words, if you attend the class meetings on Sept 1, Sept 8 and Sept 15, you will get 3 extra credit points added to Exam 1. Education is not a passive activity. Just as in the professional world, showing- up is essential to success. Also essential is having your zoom camera on and your name written as it matches for the class. Material presented during the class meetings will not be from the book, the sessions will NOT be recorded and content may appear on the exams. Trust me, this class requires you to study and keep up with the materials. Staying on top of the weekly materials and assignments allows you to consider and understand the topics we will cover, practically ensuring a higher grade in the course than if your attendance is sporadic. Evaluation of Coursework

The evaluation of coursework will be based on the student's performance in three major areas, each of which constitutes a proportion of the final grade:

Assignments: 20%

Public Relations is not something you can simply read about or attend a class and know. It takes a lot of work. Throughout this course, we will do a variety of assignments. This work will not only count toward your grade, but also help give you experience applying what you are studying. In public relations, deadlines are extremely important, so I typically do not accept late work. But, we are likely to be impacted by COVID, hurricanes and other life events this semester. Because of this, I will give you the opportunity to submit late assignments for a point deduction. Each assignment is worth a max of five points. For each 24 hours an assignment is late one point will be deducted – note that one minute late also equals one point. Don't put off your assignments! BUT, again because this is likely to be a bumpy semester, I will drop your lowest assignment grade.

Three Exams:

The exams will be over the chapters listed and the "area of focus" covered in the weeks for those chapters. Each exam will be 50 multiple choice questions. A makeup exam will be provided for student who miss an exam due to extreme, documented circumstances. You need to notify me ASAP and provide documentation. Exams are only open during a 24-hour window that starts at 12:01 am on the day it is due and will close at 11:59 pm that day. You can only take it once (no repeats). Exam 1: 15% - Sept. 22

Exam one will be closed-book and cover Chapters 1, 2, 3 & 4.

Exam 2: 20% - Oct. 20

Exam two will be closed-book and cover Chapters 5, 6, 7 & 8

Exam 3: 25% - Dec. 15

Exam three will be closed-book and cover Chapters 9, 10, 11, 12, 13 & 14

Public Relations Specialization Report: 20% - DUE Dec. 10

This assignment is to research a particular public relations specialization. This can be either be something you would like to find information to aid your career search or something of interest to you. Once you pick your specialty, you will pick an organization to focus on for your report. This is something you can start thinking about right away. Details will be distributed soon.
