

# MMC 4200: Law of Mass Communication SUMMER C 2019 (Online) Section 12576



## Course Goals

This course introduces you to First Amendment jurisprudence, as well as to common law and statutory law as they affect journalists, the media and, more broadly, all citizens of the United States. The course covers the historical underpinnings of the First Amendment freedoms of speech and press, theories and rationales for protecting speech, and the laws of prior restraint, libel, privacy, trespass, hidden cameras, newsroom searches and other situations that journalists confront. Furthermore, the course addresses a wide-range of topics that affect everyone, including broadcast indecency, obscenity, child pornography, fighting words, incitement, threats of violence, advertising (commercial speech and FTC regulation), high school student speech rights, copyright and trademark.

### Exams: (Weeks 4, 9, 13)

The course will consist of three *non-cumulative* exams, each covering about five weeks worth of course material. Exams will be posted on Canvas at 9:00 AM on the Monday of exam weeks and will be due by 5:00 PM on Friday evening. There will be no additional readings to complete during exam week.

### Discussions (Weeks 1, 5, 10)

Because we will meet electronically, you will be placed in small discussion groups during certain weeks. You will be given a prompt related to the topic of that week's readings. For each discussion, you will be expected to provide **one 300 word response** and at least three **100 word** reactions to your fellow discussion mates.

### Self-Reflections (3, 6, 11)

Self-Reflections will provide you an opportunity to place yourself in the middle of our topic. I will give you a prompt and ask you to provide a **500 word response** to the prompt.

### Quizzes (Weeks 1-15)

As this is a media law course, there will be a consistent carousel of current events relating to news, media, and the law during the Summer of 2019. You will complete a 10-15 question quiz at the beginning of each week. **Quizzes will be due by 11:59 PM on Thursday.**

### Extra Credit

You can get up to two (2) bonus points for MMC 4200 which will be added to your final grade. To do so, you must attend either a (1) Local School Board Meeting, (2) Local City Council Meeting or other official government meeting, and/or (3) 1 hour attending a local courtroom hearing in Gainesville or in your hometown. ## ONLINE COURSE RESPONSIBILITIES

As this is an online class, technology errors are prone to occur. # Canvas Information

## Modules

Starting by 10:00 AM on each Monday, the weekly course module will open. Modules will consist of a PDF class lecture, weekly current events quiz, and discussion (when applicable). During exam weeks, no PDFs or quizzes will be posted.

Modules will not be posted in advance - prepare in advance to complete the weekly readings, lectures, and assignments. There is some built-in flexibility to give you a few days to complete each assignment.



## Assignments & Expectations

There are three key assignments for this course: exams, discussions, and quizzes.

**Exams** will consist of multiple-choice, true/false, and short answer questions. Exams will cover the material in the PDF lectures and the readings listed in the course schedule. **EXAMS ARE CLOSED- BOOK, CLOSED-NOTES, AND YOU MUST WORK ALONE.** You will be asked to electronically sign an honor pledge noting that you did not receive any unauthorized outside assistance in completing the exams. Exams are non-cumulative and each exam is weighted equally (20%) for your final grade. The first ten students to send me their top favorite three TV shows of all-time will get three bonus points on their first exam. All exams will be due by Saturday at 5:00 PM

**Discussions and Self-Reflections** provide an opportunity to meet with each other about a current legal issue that will connect with the course material for the week or self-reflect about your stance on a topic. You will be asked to provide a response (~500 words) to the case - with direct connections to the course readings. Discussions will place you in small groups (around 5 students in each group) and you will need to include a response (~100 words) to your fellow discussion mates. **Discussions should not be a one-way street - in other words, responses such as "Great Response!" - will not receive full credit.** Consider including questions in your response to garner a fuller discussion experience (and receive more points). All initial discussion posts and self-reflections will be due by Wednesday at 5:00 PM. Discussion responses will be due by Saturday at 5:00 PM. Late posts and responses will incur a half-grade penalty.

**Quizzes** are weekly checks to ensure you are completing the weekly readings as well as keeping up with current events in news, media, and law. Quizzes will take place on Canvas and consist of 10-15 questions. Unlike exams, quizzes are open-book, open-notes, and open-Google. **Once you open the quiz, you must complete it in one sitting and have only one opportunity to complete it.** All quizzes will be due by Thursday at 5:00 PM. Late quizzes will incur a half-grade penalty.

## Make-up Assignments

For this online course, there are no definitive days and times which you must be present to complete an assignment. However, life happens, and if you must miss an examination or other assignment due to a serious family emergency, or your participation in an official University activity such as an athletic event, you must notify me by e-mail at least 48 hours in advance of the exam week. Make-up exams without such prior notification will only be allowed due to clearly documented medical excuses or a death in your immediate family (spouse, sibling, parent, child, or grandparent). You will need to provide me with clear documentation and details to verify the excuse. It your responsibility to contact me by e-mail at [ckearney1@ufl.edu](mailto:ckearney1@ufl.edu) no later than 24 hours following the time of a missed exam. You will not be allowed to take a make-up exam if I do not receive an email from you within 24 hours following the time of a missed exam. Otherwise, missed exams will result in a grade of zero. ### OFFENSIVE LANGUAGE ALERT

This class largely is about freedom of expression. You will be reading about (and discussing in groups) cases involving language that may offend some of you. This language will be used in class to the extent that it is germane to the subject matter. The First Amendment, as you'll discover from reading *Cohen v. California* protects a vast amount of speech that some people find offensive. The U.S. Supreme Court must (and does) address cases involving offensive speech, and so will we.
