Required Texts

No texts are required, but you should be a voracious reader of the local Gainesville high school sports coverage.

Course Summary

This class is designed to support your experience as you serve as a Sports Communication Officer for a Buchholz High School and Gainesville High School fall sport. This class provides you real-world, on-the-field experience in sports communications. As an SCO, you will create original content for your respective sport and athletes and attend all your assigned sports' events to get game and player statistics to support media coverage. You will build relationships with administrative staff, coaches and local sports reporters and editors and be the primary contact between coaches, athletes and the media.

Course Learning Objectives

This course will improve your understanding of the following:

- Understand the role of an SCO during games/events, including event management and establishing media policies for your respective sport
- Understand the relationship between SCOs and journalists/editors
- Understand the relationship between SCOs and coaches and athletes
- Understanding of how to work with journalists/editors on game coverage
- Understand how to work with journalists/editors on feature coverage
- Understand how to create internal content to help support your sport and athletes

Attendance and Active Participation: 25%

Sports coverage: 75%

- Your work with reporters/editors and performance at sporting events will comprise the majority of your grade in this class.
