1. Call to order and minutes from 10/07

Executive Associate Dean Kiousis visited and:

- announced there is discussion for new four-level annual review system (compared to current Satisfactory/Unsatisfactory) to be implemented.
- said the CJC constitution is being reviewed by CJC senate and invited faculty to participate.
- encouraged faculty to increase student evaluation response rates.
- provided an update on HB1 visas, but federal rules are still being clarified, so there's uncertainty still.

Coche spoke of Ocala film festival for middle and high schools in which MPMT has been asked to speak.
